The Annual Meeting of the UK-Japan 21st Century Group is in the UK this year over the weekend of 19 – 21 March. The Group plays an important role in UK-Japan relations and this lunch will provide its delegates with a particularly appropriate and useful start for the meeting, and give Japan Society members a good insight to what will be discussed. Seated at tables of approx. 8 people, participants will have the opportunity to share views on topics likely to form part of the weekend's discussions.

The objectives of the UK-Japan 21st Century Group are to advance the education of the citizens of the United Kingdom and Japan in all aspects of each other's public institutions and systems of government, as well as each other's political and economic institutions, industry, social sciences and culture. The British and Japanese members hold an annual conference, alternately in Britain and Japan. Following each conference the two co-Chairmen submit to the two Prime Ministers recommendations formulated by the Group at the conference, notably on ways in which cooperation between the two countries might be enhanced. These recommendations are fed into Whitehall policy on Japan.

The Group is composed of senior parliamentarians, business executives, journalists and academics. The meeting on 19-21 March will discuss trade, investment and financial flows; the changing global geo-political structure; and strategies for climate change policy after Copenhagen. It will also review the outlook for UK-Japan relations and progress in developing bilateral collaboration. This will be the Group's first meeting since the change of Japanese government. The Japan Society lunch will be in tables of 8 – 10 and provide an opportunity both before and during the lunch to meet the Japanese and UK participants attending the Group's meeting and exchange views with them on the subject matter to be discussed at the meeting.

UK-Japan 21st Century Groupの年次総会が、3月19日～21日にかけて本年は英国で行われます。このグループは日英関係において重要な役割を果たしています。この昼食会は、グループの代表者の方々にとっては、会議前の準備としてふさわしく、会員の方々にとっては、どのような議題が上がるのかを知ることができ、会議に貢献できる機会となるでしょう。

UK-Japan 21st Century Groupの目的は、英国、日本において相手国の公的機関や政府のシステムならびに政治・経済機関、産業、社会科学や文化の全側面についての人々の理解を深めることです。両国のメンバーが、交互に年次総会を主催しています。会議後には、二名の共同議長が両国の首相に、グループより出された、特に両国間の協力が強まる方法についての勧告書を提出します。これらの勧告は、英国政府の日本政策に取り込まれていきます。

このグループは、上位の国会議員、企業幹部、ジャーナリスト、学者の方々で構成されています。今回の会議では、貿易、投資、資金フロー、変化し続ける世界規模での地政学の構造、コペンハーゲン会議後の気候変動政策の戦略について議論される予定です。日英関係の展望や二国間協力が発展してきているか、についても確認されます。今回は、日本の政権が交代してから初めての会議となります。

ランチは、8人から10人掛けテーブルでお召し上がりいただきます。お食事前やお食事中には、会議に参加される代表者の方と会議での議題について意見交換をなさる機会があります。

お飲み物は、12時30分より1時まで1階のライブラリーにて、また昼食はThe Lloyd George Roomにてお召し上がりいただきます。
