# Minutes of the 116<sup>th</sup> Annual General Meeting of The Japan Society

Held at the Embassy of Japan, 101-104 Piccadilly, London W1 at 6.00 p.m. on Thursday, 27 June 2013

## Chairman's Welcome

Sir David Warren, the chairman, opened the meeting by welcoming all those present; he gave a particular welcome to the Society's President, the Japanese Ambassador, Mr Keiichi Hayashi. This was the Ambassador's third AGM since his posting to the Embassy in early 2011. He invited the Ambassador Hayashi to make a few comments.

### Ambassador Hayashi

Despite the Japanese proverb *ishi no ue ni mo sannen*, Ambassador Hayashi's three years in office had been far from a gradually warming up process. Quite the contrary, it had almost felt as though he were hopping over hot stones, with the Tohoku earthquake, followed by the visit of the Emperor for the Diamond Jubilee, the Olympics and the G8 summit. Throughout this period the Japan Society had been an active support since his arrival, for which he thanked its members.

Ambassador Hayashi welcomed David Warren to his first AGM as chairman. Since taking up the post in January, he had applied himself with gusto and the Japan Society would clearly continue to thrive under his leadership. This continued to be a busy time for UK-Japan relations: last week Prime Minister Abe visited Northern Ireland for the G8 summit, before which he held a valuable bilateral meeting with Prime Minister Cameron and which was followed by a speech on his economic policy at the Guildhall in the heart of the City. This event was also supported by the Japan Society so many members would no doubt have been there or have read the speech. It was a very robust manifestation of the Japanese Prime Minister's determination to pursue and bring to fruition a series of major structural reforms in order to revitalise the Japanese economy.

2013 saw a series of events celebrating the longstanding friendship between our two countries. In July major events would remember the arrival one hundred years ago of five future leaders from Choshu who came to study this country's advanced technology. This marked the start of academic exchange, which the Japan Society had continued to promote in more recent times.

A series of events were also underway under the banner of Japan400, which marked the passage of exactly four centuries since England and Japan embarked on a relationship of sorts following the arrival in Japan of an English ship.

These initiatives testified to the long standing and forward looking friendship which our two countries enjoyed today. In this regard the Japan Society continued to play the vital role it had performed for over a century.

Ambassador Hayashi thanked everyone at the meeting for their efforts to maintain and build upon these links. He hoped the Japan Society would continue to go from strength to strength under its new leadership.
